 - recycle they are trying to get it for no cost.
- Public works person from the County is on the Point 1 hr each week at the Library to deal with problems.
- sponsored a forum on logging. Those doing the logging were violating their permits. The County hopes to stop this by increasing the bond posted.
 - meetings on the 1st Wed. of each month at the Library.

DRAINAGE

- Don Rathborne reviewed all that had been done since the slides of Jan 1 1997. A State geologist came up and walked the areas of concern. The Directors then decided to have W.D. Purnell prepare an engineering proposal for us. Refer to previously-circulated proposal. Following an open and frank discussion M. Lil Watts and S. Ron Tully that Plan C of the Capital Fund Budget be approved. CARRIED (See attached budgets).

This is a special capital assessment to ALL property owners of \$100.00 CDN per LOT to pay for the required repair work as recommended by the engineering plan - all to be carried out as soon as possible.

ANNUAL DUES

- M. Jack Jones, S. Neil Menzies that the dues for 1997 - 1998 be increased by \$10.00 from last year to \$50.00 CDN. CARRIED. This is \$44.00 for C.W.B.C.A. common property purposes plus \$6.00 for the Pt. Roberts Taxpayers Association. This is the required annual dues per member as reflected in the proposed operating budget for 1997 - 1998 (see attached budget as approved).
