Clarification of Roles, Responsibilities and Liabilities of Crystal Water Beach Tidelands Association (the "Tidelands Association" and the unincorporated Crystal Water Beach Association (the "Main Association").

We want to reduce the need for obtaining directors/officers insurance for the Tidelands Association by clarifying the Tidelands Association has no liability or responsibilities for Reserve "A" common property or any other activity at CWB.

RESOLUTION #1: The members of CWB endorse the following governance and oversight approach to managing community activity and managing liabilities and risks.

The Tidelands Association is strictly limited in scope and capacity to entering and administering an agreement known as the Right of First Refusal & Mutual Access Agreement (the "Agreement") on behalf of owners of CWB. The Tidelands Association has no other role or responsibility beyond what is needed to enter and administer this Agreement. Importantly the Tidelands Association has no liability for any other activity in the CWB community, on CWB lands, or on the tidelands themselves.

The Main Association is responsible for all community matters as it has historically performed including managing the community raft each year, maintaining stairways, and maintaining common property on Reserve A and similar activities.

The Main Association indemnifies the Tidelands Association and its directors and officers against all liability and claims related to CWB activity. Main Association will indemnity, defend and hold harmless the Tidelands Association and its directors and officers in case of any claim against such persons for issues that are the responsibility of the Main Association.
